FORGIVENESS OF DEBT BYLAW

A bylaw of the Hamlet of Enterprise in the Northwest Territories pursuant to the *Hamlet's Act S.N.W.T. 2003, c.22 Section 124.*

WHEREAS the council of the Hamlet of Enterprise is satisfied that certain debts owed to the Hamlet are uncollectable or that there are other reasons justifying the forgiveness of the debts;

NOW, THEREFORE, the Council of the Hamlet of Enterprise, at a duly assembled meeting, enacts as follows:

1. SHORT TITLE

That this bylaw may be cited as the *"Forgiveness of Debt Bylaw."*

2. FORGIVENESS OF DEBT

- a. The Council of the Hamlet of Enterprise is satisfied that the debts owed to the Hamlet that are identified in Schedule "A" are uncollectable or that there are other reasons, set out in Schedule "A", that justify the forgiveness of the debts.
- b. The debts owed to the Hamlet that are identified in Schedule "A" are forgiven in full.

3. SEVERABILITY

Each provision of this Bylaw is independent of all other provisions. If a court of competent jurisdiction declares any provision invalid for any reason, all other provisions of this Bylaw shall remain valid and enforceable, and the Bylaw shall be interpreted as such.

4. READINGS
